***10cy** is mainly used for construction material/mixed waste. **NO CONCRETE, ROCK, DIRT & ASPHALT.**

***15cy** is mainly for **CONCRETE, ROCK, DIRT & ASPHALT.**

***30cy** is mainly for construction material/mixed waste with **limits on concrete, dirt, rock & asphalt.**

- **BIN RENTAL** rates are per load and includes two weeks usage. **It is the customer's responsibility to call the office to schedule a pick up.**
- **DUMP FEE** in excess of the first 5.00 tons of construction debris will be charged at the rate of \$57.59/ton (\$55/ton + GE tax).
- ***Overload Bins** weighing 10.00 tons and over. In addition to the dump fee, a separate fee of \$50/ton will be charged for each ton exceeding the 10.00 ton maximum.
- **DEPOSIT** is required for all new, first-time customers in the form of: Check, VISA or MC. Overpayment on a deposit will be refunded.
- **GREEN WASTE ONLY**, no dirt, no plastic bags. Tree stumps must be 4' X 4' or less. Call for dump fees.
- **CARPET** loads (40% carpet) are charged at \$102.62/ton (\$98/ton + GE tax) with a 3.00 ton minimum.
- **STANDBY TIME** in excess of 15 min. will be charged at the hourly truck rental rate (\$119.34/hr + GE tax).
- **RELOCATION** of bins have a one hour min. charge at the hourly truck rental rate (\$119.34/hr + GE tax).
- **INACTIVE BIN CHARGE** of \$10/day, \$50/week, \$200/month, will apply for bins held over the two week allowance. **It is the customers responsibility to call the office to schedule a pick up.**
- **ADDITIONAL SERVICE/HANDLING FEES** will be assessed for any load containing **Prohibited/Unacceptable Material(s):**
 - *\$98.00 min. for assistance to reload/unload, \$50 to haul away for proper disposal + \$50 min. per item.
 - *\$150.00 min. for assistance to empty wedged/trapped debris.
 - ~Hazardous Materials - Flammable, Radioactive, Chemicals, Medical Waste, Paint, etc.
 - ~Auto Parts & Cleaners - Tire, Battery, Solvent, Antifreeze, etc.
 - ~Appliances - Refrigerator, Freezer, Air Conditioner, Microwave, etc.
 - ~Others - Mattress, Computer, Copy Machine/Printer, Television, Electronics, etc.

- **DAMAGES/GRAFFITI** to bin and property will be the customer's responsibility.
- **SPECIAL REQUESTS** for services before/after our normal business hours and for a specific time, a \$100 minimum charge will apply.

We request that you call at least one day in advance for bin rental and/or bin pick up.

Due to the nature of our business, we cannot guarantee scheduled drop-off/pick-up times.
